Pursuant to the Court's June 23, 2020 Order re: Plaintiff's Motion for Final Approval of Class Action Settlement (Dkt. No 60), the Northern District of California's Procedural Guidance for Class Action Settlements, and the Class Action Settlement Agreement and Release (Dkt.
